## 2025 Dog Licenses

All dogs in the Town of Farmington must be vaccinated against rabies and must be licensed by 5 months of age.

A dog license can be purchased between now and March 31 to avoid a late fee and citation. Proof of current rabies vaccination is required to license your dog..

The fee to license your dog is \$12.00 for an altered dog and \$23.00 for an unaltered dog..

If you fail to license your dog by March 31st, you must purchase a dog license from the County Clerk's office and pay a late fee of \$25.00 plus the cost of the dog license. This also applies if you get a new dog and fail to license it, if your puppy turns 5 months old and you fail to license it, or if you move into the township and fail to license it within 30 days.
